4. Guest Speaker – Jason Craft (Upcoming Murals)

Jason presented two designs that he has been working on. The mural to go in the gymnasium will feature a family of cougars as well as eagles flying. The other mural will feature the Crescent Park Annex and will go in the hallway between the office and the gymnasium. Feedback was positive with a suggestion to put the established date on the Annex to acknowledge the history of the building.

5. Guest Speaker – Beverley Bunker (Roots of Empathy)

Ms. Bunker (Grade 6/7 Teacher) outlined a program her class is involved in that matches the class with a local baby and mother who visit the class throughout the year. Through the program, students learn how babies develop and in addition, the program helps students develop empathy and awareness about how people's emotions are shown. Different ways of exploring self-regulation and making connections with students who are old enough to babysit are also goals of the program.

7. Other Business

The group discussed ways of celebrating the season in a way that would not be disruptive to teaching and could include the entire school. Some past activities like the lantern walk were not attended by the entire school and other activities took away a great deal of instruction time from teachers. One parent suggested that we do a Pancake Breakfast on the last day of school. It was a popular tradition at their previous school and could include a visit from Santa as well as carol singing etc. It was decided that we would have a Breakfast with Santa on the last day of school. Carla P. offered to coordinate.

Cobbs Bread

An inquiry has been made to Cobbs Bread regarding the school fundraising program– we are waiting to hear back.
